This must include hours of study/units/credits, grades/marks/examination results, issued in the original language. After a preliminary review of the records, a syllabus/program description may be requested from the applicant that provides hours/units/credits. If documents are not in English, certified translations must be attached. Please call or email with country-specific documentation questions.

3. MISCELLANEOUS

- **a.** Credentials: Legible, official copies of all original language documents must be submitted with certified English translations. If original documents are necessary, they will be requested. ESI reserves the right to request documents directly from the issuing institution and/or the applicant.
- **b. Translations:** Photocopies of original language documents, from which certified translations have been made, must be attached. Non-English speaking countries whose institutions issue records directly in English, must submit English records.
- **c. Document Request:** In case of insufficient information or incomplete documentation, a REQUEST FOR ADDITIONAL DOCUMENTATION WILL BE ISSUED. An Evaluation Report will be issued only after all materials have been submitted. Failure to respond within twelve months will result in the termination of the application and forfeiture of all fees.
